

Millersville Board of Commissioners
Minutes of Special Meeting
Tuesday, September 26, 2023 at 6:00 P.M.
at Millersville City Hall

The Millersville Board of Commissioners held a special meeting at City Hall on Tuesday, September 26, 2023 at 6:00 P.M. with the following board members present: Tommy Long, Mayor; Milton Dorris, Vice Mayor; Commissioners: David Gregory and Cristina Templet. Also present: Scott Avery, City Manager; Holly Murphy, City Recorder/Finance Director; and Jack Freedle, City Attorney

1. Call to Order.

Mayor Long called the meeting to order at 6:00 P.M.

2. Invocation and Pledge of Allegiance.

Mayor Long gave the invocation and led the Pledge of Allegiance to the Flag.

3. Resolution of the duties required by Chapter 18 and Chapter 90 of the Millersville Code of Ordinances to provide building and other inspection services for the public safety of the community.

a) **Resolution 23-R-23**, a resolution to award the building inspection and plan review services contract and authorize the city manager to sign the contract.

Commissioner Gregory made a motion to approve Resolution 23-R-23, seconded by Commissioner Templet. (Vote 2 yea – 2 nays, with Vice Mayor Dorris and Mayor Long voting no.) **Motion failed.**

b) **Resolution 23-R-24**, a resolution approving the hiring of a full-time building inspector.

Commissioner Gregory made a motion to approve Resolution 23-R-24, seconded by Commissioner Templet. (Vote 2 yea – 2 nays, with Vice Mayor Dorris and Mayor Long voting no.) **Motion failed.**

c) **Ordinance 23-804**, an ordinance repealing all building and planning codes that require the city to provide building and other inspection services.

There was no motion. Ordinance 23-804 **failed** due to the lack of a motion.

4. Appointment of one (1) person to the vacant commissioner seat.

Vice Mayor Dorris made a motion to nominate Alisha Huling. There was no second. **Motion failed due to the lack of a second.**

Commissioner Gregory made a motion to nominate Tim Lassiter, seconded by Commissioner Templet. (Vote 2 yea – 2 nays, with Vice Mayor Dorris and Mayor Long voting no.) **Motion failed.**

Vice Mayor Dorris made a motion to nominate Deborah Chadwick. There was no second. **Motion failed due to the lack of a second.**

Mayor Long made a motion to nominate Jesse Powell, seconded by Vice Mayor Dorris. (Vote 2 yea – 2 nays, with Commissioners Gregory and Templet voting no.) **Motion failed.**

Mayor Long made a motion to nominate Steven Heicher, seconded by Vice Mayor Dorris. (Vote 2 yea – 2 nays, with Commissioners Gregory and Templet voting no.) **Motion failed.**

5. Adjournment.

Vice Mayor Dorris made a motion to adjourn, seconded by Commissioner Gregory.
(Vote 4 yea – 0 nay). Motion carried.

Meeting adjourned at 6:15 P.M.
