RESOLUTION 25-R-05

A RESOLUTION CALLING FOR A PUBLIC HEARING ON THE PROPOSED ANNEXATION OF TERRITORY INTO THE CITY OF MILLERSVILLE BY OWNER CONSENT AND APPROVING A PLAN OF SERVICES FOR THE PROPERTY LOCATED AT 1824 US HIGHWAY 31W, IDENTIFIED ON SUMNER COUNTY TAX MAP 99 AS PARCEL 009.00

Whereas, the City of Millersville, having been petitioned by interested persons, proposes the extension of its corporate limits by the annexation of certain territory adjoining its existing boundaries and within its urban growth boundaries by owner consent; and

Whereas, a plan of services for the territory proposed for annexation by owner consent has been reviewed by the City of Millersville Planning Commission; and

Whereas, the governing body desires to conduct a public hearing on the proposed annexation and plan of services;

NOW THEREFORE BE IT RESOLVED BY THE CITY OF MILLERSVILLE TENNESSEE AS FOLLOWS:

A. That a public hearing is hereby scheduled for 6:00 pm on April 15, 2025 at the Millersville City Hall, 1246 Louisville Highway, on the proposed annexation of territory by owner consent, and Plan of Services, to wit:

The property identified on Sumner County Tax Map 99 as Parcel 009.00

- B. That a copy of this resolution, describing the territory proposed for annexation by owner consent, along with the plan of services, shall be promptly sent to the last known address listed in the office of the county property assessor for each property owner of record within the territory proposed for annexation, with such being sent by first class mail and mailed no later than twenty-one (21) calendar days prior to the scheduled date of the hearing on the proposed annexation.
- C. That a copy of this resolution shall also be published by posting copies of it in at least three (3) public places in the territory proposed for annexation and in a like number of public places in the City of Millersville, and by publishing notice of the resolution at or about the same time in the Robertson County Times and the Gallatin News-Examiner, newspapers of general circulation in such territory and the City of Millersville.
- D. That notice of the time, place and purpose of a public hearing on the proposed annexation by owner consent and the plan of services shall be published in a newspaper of general circulation in the City of Millersville not less than twenty-one (21) days before the hearing, which notice included the locations of a minimum of three (3) copies of the

plan of services for public inspection during all business hours from the date of notice until the public hearing.

E. That written notice of the proposed annexation shall be sent to the affected school system as soon as possible, but in no event less than thirty (30) days before the public hearing.

THIS RESOLUTION SHALL TAKE EFFECT ON ITS PASSAGE, THE PUBLIC WELFARE REQUIRING IT.
