# T.C.A. Section 68-14-801 thru 807 Katie Beth's Law

I, the undersigned, hereby swear of affirm that as part and parcel of this project a functioning swimming pool alarm has been included and will be installed prior to completion and/or use of said pool in accordance with T.C.A. 68-14-801 thru 807.

I hereby acknowledge also that I am fully aware that any violation of this law is considered a Class C misdemeanor, punishable by a fine only not to exceed one hundred dollars (\$100.00); second and subsequent offenses punishable by a fine only of not more than five hundred dollars (\$500.00).

I further acknowledge that in undertaking this project and signing this document I am agreeing to take any and all necessary steps to insure full compliance with all applicable provisions of the aforementioned "Katie Beth's Law".

This law does not apply to public swimming pools or multi-family residential housing swimming pools, as defined in

# **Swimming Pool/Spa Application & Inspection Guidelines**

#### 1) Swimming pool permit application

- a. Completed pool application
- b. Draw a site plan on back of application showing main house, any out buildings, and location of proposed swimming pool. You must be a minimum of 5 feet behind the principle structure, 5 feet from both side property lines and 5 feet from the rear property lines.
- c. KATIE BETH'S LAW affidavit signed and notarized before the issuance of a pool permit.
- d. Provide the building department with a receipt of purchase for the swimming pool alarm.

#### 2) Electrical Permit

Proof of electrical permit is required prior to pool permit issuance.

#### 3) Electrical Rough-In Approved

Call before swimming pool rough-in inspection.

#### 4) Inspections required: (24-hour notice required)

- a. Above ground pool Need Rough-In / Set-back inspection for the swimming pool
- b. **In-ground pool** Need Rough-In / Plumbing underground with air test on plumbing lines and set-back inspection before plumbing is covered up

#### 5) Final Electrical Inspection

This inspection is required prior to calling for swimming pool final inspection.

### 6) Final Pool Inspection

This may include fence, deck\*, and installation of all alarms.

\*If you are building a deck – please check with the building department for additional permit requirements.
