She informed the Commission that the winner of the Short Story Contest will ride on the float with Santa at the parade. She stated that the Wi-Fi and tech service use was up 150% this month. She also asked for letters of support from the community for a grant that is being applied for through the American Library Association to help support homeschool and virtual school groups to trade skills with each other through a mutual website.
